### **OPM News**

The Office of Personnel Management has sent its annual letter to the insurance companies that are part of the Federal Employees Health Benefits Program (FEHBP). OPM is again proposing that the in-

surance companies create a separate health plan for Medicare-eligible federal annuitants and expand the controversial Health Savings Accounts. We have concerns that this would open the door to separately rated retiree plans with higher premiums than other FEHBP plans. It has always been the case that federal employees and retirees were under the same health insurance plans. In addition, NARFE is disturbed that this would also lead to encouraging annuitants to join private Medicare options like Medicare Advantage and the Medicare Part D prescription drug programs and other changes which would result in higher premiums and reduced benefits for federal annuitants. NARFE President Margaret Baptiste has put out a press release about this. If you want a copy or did not get it through GEMS, let me know. Keep in mind that this is only a proposal, no actual changes have been made yet. Similar changes have been proposed in previous years which have been challenged and not made. I am sure our national office will stay on top of this and let us know of any developments.

### **Telephone Committee**

I want to express my thanks to the members of the Telephone Committee in doing a great job in staying in contact with the rest of our members. I have received several good reports from you and you are to be commended for your work. Many of our members enjoy the monthly calls, and while they cannot always attend the meetings, it helps to know that we care about our members.
