We are currently down approximately 10,000 members since the beginning of this year. Frazier outlined a particular method by which we should contact these lost members and encourage them to come back on board. We have already begun that process and hope to get good results. The coming year with the election of a new president and many new members of congress will bring many concerns for the federal employee and federal retiree and we need to remain strong to effectively work to maintain our benefits. For that reason we need to keep our member numbers up.

ity of making big changes in the way NARFE does business in the future. I certainly don't have room to write about all of them, but want to mention the more important ones. I have a book that lists of these and I will make it available at the next meeting for you to review. They are also online at the NARFE website.

#### 08-01 Expanding Membership Eligibility

This would expand membership eligibility to include all those currently eligible for NARFE membership but also any federal employee or annuitant and their family members even if they are not eligible to receive a annuity from any agency of the federal government. My comments; while this would increase the number of persons who could join, I don't think many will avail themselves of it.

#### 08-02 Abolish Automatic Chapter Membership

Currently all new members are required to also belong to a chapter, This resolution would change that, making all the current National only members full members and giving all current chapter members and new members the option whether to belong to a chapter or not. My comments; this subject of mandatory chapter membership has been discussed for many years. If this resolution is passed, it would result in many members dropping chapter membership and would weaken the chapters and the federations. This seems contrary to the main thrust of NAFRE down through the years. Chapters need to remain strong and such that members want to belong. I don't think this is the way to go.

#### 08-04, 06, 05 NARFE Association Dues

There are 3 resolutions that are very similar, each would eliminate the National Dues and Chapter Dues and create a single Association Dues. The new dues would be \$39 per year of which \$10 would be sent to the chapter that the member belongs to. This new dues structure would not affect Life Members or Honorary Members. The new rates would only apply to new members who join after the change takes place. Existing members would be grandfathered in and would continue to pay the same rates as they do now. Some chapters would be greatly affected in future years; some chapters currently have dues set much higher than \$10 and they would be affected the most. Other chapters have dues less than \$10 and they will have the option of returning the extra back to the member. My comments; while I am in favor of a single dues structure to eliminate the confusion now in the many rates we currently have, I am not sure this is the way to go about it. The fact that these new rates would only apply to future members would add to the confusion at least as long as the current members are still in NARFE. Also many members which are paying higher dues could drop out and rejoin under the new rates. We will have to study this one a bit more.

## 08-13 Automatic Spousal Membership

This would create a family membership whereby if either or both married persons are current or retired federal employees may join and the spouse is automatically a member. This would add many new members to our total membership. This would apply to all current and future members. My comments; this would mean somewhat a loss of revenue for NARFE but I believe it is a good ideal and very much needed to increase our membership totals and help with combating the existing decline in membership.

I don't have room to write about any others, but there are some that would; eliminate the National Vice President position and many more. Please attend the next meeting as we discuss these and others. You can also read about them online.
