Alzheimer's Report: A collection was made for Alzheimer's fund in amount of \$30.

The nominating committee report was presented. The report showed that no one agreed to serve as President or Vice President but for the positions of Treasurer, Myrna Estes has agreed to serve and Secretary, Reba Collins has agreed to serve. A copy of the report is attached to the minutes. After a discussion, the current President, Ronnie Collins agreed to stay on and the previously mentioned members were placed in nomination. A vote was held and all the listed officers were elected to serve for 2010. We will be looking for a candidate for Vice President.
