President Collins stated National Call Congress Day was Wednesday February 15th. Headquarters reported over 7500 calls on that day. He stated phone calls and e-mail's are always an important way to voice your concerns to Congress.

President Collins stated some of you may be aware that Congress was looking to make cuts to Federal Employees to pay for the extension of the unemployment benefits for those out of work. He said the latest news is that federal employees who are currently working will not be affected. But those who are future hired into the federal workforce will have to pay a higher percentage into FERS for retirement benefits. The increase will be from 0.8 percent to 2.3 percent.

Treasurer's Report: Treasurer Myrna Estes stated collections from dues were \$138.68, there were no disbursements and a balance of \$1231.93.

Audit Report: An Audit for calendar year 2011 done by Handley Oswalt showed a balance at the end of 2010 was \$901.54. All balances are supported by bank statements and check registers up through December 31, 2011. Current balance as of December 31, 2011 is \$1100.25. A copy of the report is attached.

Membership Report: This month's membership report shows 3 new members: Elaine Duewer, Larry Hackett and Geary Hayes. Waymon Roberts was dropped for non-renewal. Alzheimer's Report: A collection was taken for Alzheimer's in the amount of \$33. A silent auction is planned to be held at the State Convention to raise funds for Alzheimer's with each chapter bringing items to auction.

New Business: President Collins asked if anyone would be willing to serve on a Nominating Committee or Social Committee. No one at this meeting was willing to volunteer.

President Collins stated the delegates planning on attending the State Federation Convention are Phyllis Huff, Ronnie and Reba Collins. He said we are allowed up to 6 delegates.

The chapter voted to approve a \$25 gift card to be used as a door prize at the State Federation Convention.
