It authorizes a one-time payment or credit of \$581 in place of a COLA for this year. Another bill mentioned was HR 711 which reforms the Windfall Elimination Provision (WEP). This bill would benefit future Social Security Annuitants.

Sunshine Report: No one was reported.

Alzheimer's Report: A collection was taken for Alzheimer's in the amount of \$21.

New business: None.

Announcements: The next regular meeting will be March 15. The scheduled speaker is Houston Bynum Administer of the Happy Haven Home for Children.
