## **Dues Withholding, A Smart Choice**

We have had a rash of members reported to us and having be sent a Second Dues Notice. It is so very important that you help us with this. Please renew your membership when you get the first dues notice which should reach you about 2 months before your current expiration date. In the past, I am certain that many of the first dues notices did not reach our members. I would like to know if this is still happening or not. If you think that is the case with you, will you kindly let me know?

Your continued membership is very, very important to maintaining all our benefits so do keep your membership current. If you have received a phone call or letter from our Membership person Betty Robinson, then send in your dues immediately. We are counting on you.

This would be a good time to mention once again, using dues withholding as a way to pay your dues. This is by far the easiest and cheapest way to keep your dues paid. And you can stop it at anytime you decide you want to. This is available to most all retired members and their spouses who pay by the year. The only exception are those who are Life Members. We have lots of members using dues withholding, if everyone that is eligible would use this method, it would make less work for us in tracking down those that are sent the second dues notice. The way this works is, the amount of \$2.96 per month is deducted from your annuity payment by OPM. You will find a sign up coupon in the magazines or ask me for information about this program. You can sign up at any time of the year. They will not start it until your current dues expire. Give it a try, it is easy and painless.

## **Legislative News**

As you probably know the Health Care Reform bill recently passed Congress and the President has signed it into law. Some of the changes the bill provides is: Members of Congress and their staff will be required to enroll in the state exchanges once they become operational, the excise tax on high value health care plans will not be imposed until the year 2018 and the bill provides a \$250 rebate this year for Medicare Part D beneficiaries who are in the 'doughnut hole'. The May issue of the NARFE magazine will have more details on this bill as it relates to us as federal employees and retirees.

The tax filing date is fast approaching, don't forget to claim the \$250 economic recovery credit if you are receiving a federal annuity and not eligible for Social Security benefits.

A bill has been introduced to allow federal employees to invest the cash value of unused annual leave in their Thrift Savings Plan (TSP) account. NARFE is supporting this bill.
