**Legislative News**

On June 25<sup>th</sup>, President Obama signed into law H.R. 3962, legislation to temporarily arrest a twenty-one percent cut in the rate of Medicare reimbursements to health care providers, particularly doctors. On June 24<sup>th</sup>, after a month of Congressional brinkmanship, the House voted to suspend the rules and pass H.R. 3962 delaying the 21% payment cut for physicians for six months and increasing their reimbursements by 2.2 percent during that time. The Senate passed H.R. 3962 by voice vote on June 18.

August has been designed by NARFE as "Meet You Candidates Month" As you have opportunity to get to know more about the candidates running this year, try to find out how they stand on issues relating to the protection of our federal benefits among all the other issues that are important. As far as our U S Representatives, in District 6, Bart Gordon is retiring and a someone new will be elected to that office, in District 4, incumbent Lincoln Davis is running along with many others. ## National Convention

I am planning on attending the NARFE National Convention beginning the end of August. There will be many important issues come before the convention that are very important. I have received the proposed changes to our **Bylaws, Standing Rules and & General Resolutions** for this year. There are a total of 22 proposed changes. Many of these have to do with dues and many will be revised by the various committees at the convention. We have 2 copies of what has been proposed, plus they are available on the NARFE website. I would invite you to review these and let me know your thoughts. We will discuss many of them at the July and August chapter meetings and I need your input on these as I go to the convention. There will also be new officers elected to the National offices. These are critical times for NARFE as a whole and it is important for the future of our organization that the best proposals be acted upon and the best leaders get elected.

## Common Myths and Truths -By Bill Price

*Note: There are several of these type of articles and they will run for several months as space permits.*

**MYTH:** NARFE has been around a long time. Whether I join or not, or drop out or not, will not make any difference.

**TRUTH:** NARFE effectiveness in fighting back reductions in your pay and benefits is at risk. NARFE needs those who are not members to join and those who are members not to drop out. Membership numbers have dropped an average of 10,000 per year over the past five years and revenue has decreased accordingly. Overall, NARFE members have declined from 491,067 in 1984 to 306,299 as of April 9, 2010, a 37.6% loss. This has caused a steady decrease in member dues that is critically needed to maintain operations. In fact, NARFE has experienced significant operating losses over the past three years. One of the primary reasons for this result is an annual 8-percent decrease in members since 2006, which translates into over \$635,000 annual decrease in dues revenue. And, decreases in members cause increases in dues. As the National Treasurer recently reported: "Overall, NARFE's financial results for the last three years indicate that it is time for NARFE to increase its national dues, coupled with more stringent cost-cutting steps." Even worse, if the trend continues, NARFE will lose political clout in fighting back proposed legislative reductions in federal pay and benefits. Every single person's membership and dues is critical to NARFE remaining viable and to maintaining a strong political voice before the Congress and the President. No longer can anyone sit back and do nothing: NARFE needs additional members and financial support via dues and contributions to NARFE-PAC. Failure to

join and not contribute will result in significant reductions in your federal pay and benefits. NARFE also needs all members to write their senators and representatives about legislative issues raised by NARFE. Special note to readers: ironically, if more members would join and less dropped out, there would be no need for dues increases; dues could actually decrease!
