Notes From The Last Meeting

We actually had 2 speakers for this meeting, they were Dr. Calvin Dickinson and Jennie Ivey. They have co-authored a brand new book *Soldiers, Spies & Spartans*. This book is about Civil War Stories from Tennessee. They made copies of this book available to purchase and they signed those for us at the meeting. This book tells stories from the prospective of both sides, the North and the South or as Dr. Dickinson put it, the Federals and the Confederates.

Dr. Dickenson said that this year marks the Sesquicentennial Anniversary of the Civil War, which means it began 150 years ago. There have been many books written over the years on the Civil War which lasted from 1861 to 1865 and cost many thousands of lives.

Jennie Ivey, some may remember she was our speaker a couple of years ago when she was a local librarian. She is also a journalist and writes for the local newspaper. She told us one of the stories in this new book about the Battle of Franklin. This battle took place on November 30, 1864 and she told us that it was the bloodiest 5 hours of the entire war because it took place at night during the dark hours. Here is a excerpt from that chapter; *"For five horrible hours, cannons boomed, rifles cracked, and bayonets flashed. At times, the air was so thick with smoke that those who were fighting couldn't distinguish friend from foe. By nine o'clock that evening, when the fighting finally ceased, 7,000 Confederates--including thirteen generals--had been killed,*

wounded, or captured. The Federal losses numbered 2,500 men".

In other news from the last meeting, we covered the financial report, the membership report and other normal business. Roy Byrd is taking orders for the special NARFE Pin commemorating NARFE's 90 Year Anniversary. The Pins are \$3 each and you can see him if you want to order or look in the Magazine for information. The chapter approved sending a Door Prize to the Federation Convention and agreed to have a picnic in June. More on that in another article.

Legislative Report

NARFE headquarters is opposing a bill in the U S Senate, S-644 which would eliminate the FERS annuity of federal workers hired after 2012. Not only that, but this would also eliminate any survival benefit and those affected would not be able to participate in the Federal Employees Health Benefits Program (our medical insurance plans). While I do not understand the reasoning of this bill, it does not sound like it would be the best direction to go. Neither of our Tennessee Senators have gone on record as supporting this bill.
