Government Employees and Retirees in the News

There continues to be lots of negative press in the news regarding government workers. While the main focus currently seems to be with state government workers and their advantages on pay and benefits, I feel like the public is likely to associate federal workers in the same mind set. From what I am hearing, state workers are getting much better benefits than those which are offered to federal workers. For instance, generally state workers do not have to pay into their retirement system and do not have to pay part of the health insurance premiums, quite to the contrary of the federal workers.

Also in the news, is the continuing saga in Washington DC in what Congress is likely to do to address the runaway federal spending. There will be cuts made and some will be directed towards federal employees and federal retirees.

I would encourage each of you, to speak out on your defense to disassociate the state workers from the federal workers and to take every advantage to let your members of Congress know how you feel with the federal spending cuts being offered. The NARFE national officers and staff are working hard to keep us informed and to provide us easy ways to contact our elected officials.

Let me remind you, if you have access to email to sign up for the legislative information that is sent out by GEMS (NARFE's Global Electronic Message System). If you are not getting these GEMS messages, send me an email and allow me to get you signed up. Everyone can call toll free 877-217-8234 to hear read the latest Legislative Alert message. Call at least each week since it is updated weekly.

Remember to use the NARFE provided toll free Washington Switchboard number 866-220-0044 and the email system on the NARFE website, Legislative Action Center to directly contact and respond to current legislative proposals (go to narfe.org and click on the **SPECIAL ALERT** banner).

It is extremely important that you maintain your NARFE membership in order that we have a strong voice on Capital Hill. **The benefits you save may be yours!!**
