#### Dues Withholding: A Win/Win Program

Dues Withholding is a program that allows federal retirees to have their NARFE dues withheld from their federal annuity on a monthly basis AND save. It provides a convenient, discounted payment plan for our retired members, spouses of retired members and survivor annuitants. It also helps NARFE keep down administrative costs while boosting retention. Dues Withholding applications are included with the renewal notices mailed to every retired member I can also provide you with a form to switch to Dues Withholding at any time.

First of all the NARFE member wins with Dues Withholdings. There are many members who want to remain members, but forget to send in their renewal check each year. We all are very busy and sometimes the renewal notice gets set aside and not acted upon. Many of our members go into a lapsed status and later are reinstated, which is some indication that they meant to renew but for some reason failed to on time. Dues Withholding prevents this from happening, Your dues are conveniently deducted from the annuity payments and you never receive a Dues Notice The fact that the dues is spread out over 12 monthly installments is also beneficial to many members. Members on Dues Withholding save 15 percent on the National Dues amount. Who wouldn't like that?

Dues Withholding is also a Win for our association and our chapter. It saves NARFE the costs of processing renewal notices and for those who lapse, reinstatement mailings. It keeps our current membership base strong and stable. Nationally, 27 percent of qualified members participate in Dues Withholding. For our chapter, we have 35 percent of qualified members taking part.

I would like to see an increased number of you take advantage of this time and money savings program. For our chapter, the amount that comes out of your annuity check is just \$3.75 per month. And if you and your spouse are both members, the cost of both memberships can be deducted. The only members who cannot use Dues Withholding are Life Members and Active Federal Employees.

For those of you who receive this newsletter by postal mail, and eligible for this program, you will find a brochure about the Dues Withholding program which includes the form you can use to sign up. For those of you who receive this by email, you can click on this link and get a copy of the same brochure and application form. Sign up today and help yourself, our National office and our chapter. Thanks.

Plan now to attend as many monthly meetings as you can in this year of 2014. Your support is needed.

#### **Legislative News**

The recent budget deal reached between in Congress and signed by the President includes among other items, a 1.3 percent increase in retirement contributions for new hires. New federal employees hired after January 1, 2014 will contribute 4.4 percent of their salary towards retirement, with no increase in benefit. Also there was a provision to add the "self plus one" option to the Federal Employees Health Benefit Plans. OPM will establish a timeline for the new option to come available, but it could be as early as the 2014 open season. As a result of this budget agreement, there should not be any federal furloughs in 2014 and 2015.

The agreement to re-open the government in October 2013 included suspending the debt ceiling until February 7, 2014. The Treasury Department has methods in place that could extend the next debt ceiling increase beyond that date, but another fight to raise this ceiling will come by March.

The Senate bill S. 1486, the Postal Reform Act of 2013 is currently stalled in committee, but expected to be marked-up this month. NARFE is on record of strongly opposing this bill as it would negatively impact **all** FEHBP participants, as well as employees receiving workers' compensation.

One Congressman has expressed interest in introducing a larger FEHBP reform bill, but details have not been released publicly.

#### **Postal Rates To Increase**

Effective January 26, 2014 it will cost 49 cents to purchase a First Class stamp. Up until that date you can purchase the Forever series stamps at 46 cents and they can continue to used forever. If you do much mailing, you may want to buy up some stamps before the rate increase. This is highest increase in the First Class rate in a few years, recent years the rate has gone up 1 cent at a time. There will also be a 1 cent increase in the Postcard rate, making it cost 34 cents to mail a postcard.

This is expected to generate \$2 billion in new revenue for the U.S. Postal Service and help improve its financial situation.
