Work is done mostly by volunteer labor and those receiving the houses must put in much of the work on a house. There are over 4000 households in Putnam Co with housing issues that need to be helped. They can always use volunteers and donations to their ReStore, which takes building materials, appliances furniture, home décor and much more to sell for the purpose of raising money to carry on their mission.

#### **NARFE-PAC**

I am sure that you are aware that 2014 is an election year and that in March every year, we place an emphasis on the NARFE-PAC. While our PAC is not as large as many others, it raises a sizable amount of money to help elect members of Congress which favor NARFE and our legislative goals. While you can contribute at any time, now is a good time to do so.

I would encourage you to read the article in the March issue of the magazine which begins on page 32. That should explain all about it and answer any questions that you might have. Also notice the wrapper in this month's magazine, it contains a handy envelope that is pre-addressed and postage-paid that you can use to send your contribution. Even if you can't send something now, save this envelope for when you can use it. That is the easiest way to make a contribution. Always remember to include your member ID number so that our chapter gets credit for any amount that you send.

You can contribute any amount that you wish, the suggested amounts are: \$20 Basic Level, \$50 Silver Level, and \$100 Gold Level. You will receive a special 2013-2014 pin in response. There is also a place to donate a monthly amount if you wish. If you would rather, you can bring a check to our meeting this month and I will see that it gets sent in. #### **Legislative News**

The Postal Reform Act of 2014 was recently approved by the Senate Homeland Security and Governmental Affairs Committee. S. 1486 now awaits consideration by the full Senate. The bill would severely diminish or authorize the elimination of longstanding employee benefits, including changes to workers' compensation for federal and postal employees disabled by work-related injuries and illnesses. It also eliminates the promise of retirement income security for the next generation of postal employees, and includes changes to the Federal Employees Health Benefits Program for postal employees and retirees. President Beaudoin urges each NARFE member to use our Legislative Action Center to send a message to both your senators opposing S. 1486.

The Chained CPI will not be included in President Obama's budget submission for the 2015 budget. That does not mean however that the Chained CPI would not be brought up by legislative action. You are urged to say alert to this.

They will be proposing a resolution to reduce the National Officers to just 2, National President and National Treasurer. Also they will reduce the number of NARFE regions from 10 to 5 when the new board is seated.

The Co-Chairman of that committee, Bill Shackelford will be our main speaker at the state convention this year and I am sure he will have much to say on the work they are doing. Anyone desiring more information on the work of the committee that does not access to what has been made available, just let me know what you need. Stay tuned for much more on this.

I am thankful to have Dan Hilton as our new Legislative Chairman helping me keep up with all the latest news in regards to legislation. He will be reporting to us month by month.
