Notes from last month

Well, the year is moving on, Spring is here, can Summer be far away? Thanks to each of you who came out to our March meeting, we had a good number out. Special thanks to our newest member, Bob Whiteman and his wife Crickett who were there for the first time. We also had 1 non-member guest who may be a potential member.

The speaker was well received, he was the newly elected Sheriff of Putnam County, Eddie Farris. He told us that he grew up in Putnam County and began his long career by working for the Sheriff Department. then later working for the Tennessee Highway Patrol, Tennessee Bureau of Investigation and Federal Bureau of Investigation.

He began serving as Sheriff on September 1st and has made many improvements to that department, which includes such items as; updating the uniforms, patrol cars and bringing in more experienced members of the department. He said that Putnam County is the 18th largest county in the state and he has 143 employees which includes 64 deputies. They currently have 255 inmates in the local jail.

When asked what the biggest problem is that they have, he said it was dealing with the illegal use of prescription drugs. This leads to many other crimes such as burglary. He said that all law enforcement departments also have this problem.

In other news, we went over all the latest reports, and encouraged those in attendance to support the NARFE-PAC by taking advantage of the form and envelope attached to the March magazine. The chapter agreed to use the Alzheimer's donations from the January meeting and the March meeting to cover the costs of a quilt to be sold during the silent auction at the Federation Convention. All the items donated there goes to support Alzheimer's research. The chapter also agreed to provide 2 \$25 restaurant gift cards as door prizes for the upcoming Convention.

Legislative news

At the March meeting, Dan Hilton mentioned several new bills which have been introduced in the new session of Congress that could have affect on both retired and current federal employees.

- HR 973, A bill to repeal the Government pension offset (GPO) and windfall elimination provisions (WEP). NARFE supports this bill.
- HR 1230, A bill to adjust the calculation of average pay for purposes of federal retirement annuity to 5 years. NARFE opposes this bill.
- HR 313, A bill to provide leave for the purpose of undergoing medical treatment to any new federal employee who is a veteran with a service-connected disability. NARFE supports this bill.

Those of you with computers are urged to follow these and other bills on the NARFE national website, [Legislative Action Center](#). There you can also learn about the Key Issues, learn about these Bills, and Contact your members of Congress by sending them a pre-written letter (which you can edit) on any of the upcoming matters that you may support or oppose.

There is lots more information that NARFE provides about legislative matters that you will find on that website section. This includes Issue Briefs and Fact Sheets, House and Senate Schedule. You will also find the latest information from the recent NARFE Legislative Conference that was held in Washington DC. Check it out!

News on health insurance

The Office of Personnel Management (OPM) is asking the plans that participate in the Federal Employees Health Benefit Program (FEHBP) to add a new category to the list of plans for next year. Currently there are plans for Self and the Self and Family, the new plans will be called Self Plus 1.

The new plans have been in the works for a few years now and are designed mostly for married federal workers that have no children, but the plans will also be available to retirees who have no dependent children.

Initially the Self Plus 1 plans are expected to have lower premium rates. But they say that the bad news is that if a lot of retirees with higher medical bills switch to the new plan, it could result in higher costs.

So when the new plans are made available, during the Open Season that comes at the end of this year, you may want to consider making a switch.
