### Notes from last meeting

He had so many good points on fire safety that I do not have space here to mention all of them. He did provide us a booklet that contains a lot of the information that he had to share with us.

He said that we are entering the time of the year when most home fires and fire deaths occur. That is the time from Thanksgiving through Christmas. The main reason, he said was from unattended cooking. Many fires are started when cooks walk away from the stove to take care of other things in the home and something happens that causes that is cooking to catch fire. Be extra careful about that and do not walk away from the stove when cooking..

The way homes are constructed these days, makes them even more dangerous if a fire breaks out. Because of the materials in homes they burn quicker and the smoke from the chemicals means that we have less time to get out safely. Bruce said, it is best to leave the house and call 911 from a neighbor's phone or a cell phone rather that staying in the house and calling from your home phone.

You should have your heating systems checked to make sure they are in proper working condition, Always make plans to have 2 ways to escape from the rooms of your house. Have good working smoke detectors and replace them after 10 years.

He also mentioned items relating to preventing falls, and the need tor firm footing especially in bath tubs. I wish everyone could have heard his talk.

In addition, we had my report of NARFE news and reports from other officers and committees. There will not be a regular meeting in December but we did make plans for a social gathering at another restaurant in Cookeville for our annual Christmas time meeting.
