It was a very informative meeting with Judge Ronald Thurman, Chancellor with the State of Tennessee Thirteenth Judicial District. This district covers the counties of Clay, Cumberland, DeKalb, Overton, Pickett, Putnam and White. He has served as Chancellor since being elected in 2006. He said that the 13 Tennessee Judicial District was the largest in the state. In addition to being a judge, he attends church with some of the members of our chapter.

Many do not know what a Chancellor is and what sort of court cases this involves. Mr. Thurman explained his duties and the court very well, saying the title Chancellor goes back all the way to the old days of England. The Chancellor was named by and served the King of England to serve as a Court of Justice.

The types of cases that come before his court are domestic and family type issues; such as divorces, child custody, alimony and adoption. And business issues like contract disputes, property disputes and conservator cases. He also administers probate cases. Judge Thurman cautioned to take seriously when setting up Powers of Attorney.

## 2015 Federation Convention

All of you are invited to attend and take part in the upcoming Tennessee Federation NARFE Convention. This year it will be on April 20 and 21 in Clarksville TN. There you can associate with NARFE members from across the state and NARFE National Officers who will be there. Complete details are still being worked out, but the host chapters, Clarksville, Dickson and Jackson are working to make this a great convention. The special speaker from NARFE headquarters will be National President, Richard Thissen.

Registration is required and there is a cost to attend, \$50 for the full convention or \$25 for just the business session. Early registration runs till March 16th this year. We selected 3 delegate to represent our chapter at the last meeting, We can have 2 more if any of you would like to go as a delegate.

## Legislative news

The new Congress is still just getting settled in, but our NARFE Legislative Department is busy working on proposed bills to help federal employees and keeping an eye open to bills that would harm federal employees and retirees. Among the bills the bills that NARFE supports is the Wounded Warriors Federal Leave Act, which provides service-disable veterans employed by the federal government with 104 hours of paid sick time for medical leave at the beginning of their employment. This will make it easier for wounded veterans to schedule medical appointments and keep up with their rehabilitation from service-related injuries.

President Obama has requested a 1.3 percent pay raise for federal employees for FY2016, but NARFE has sent a letter to Congress with a 3.8 percent request.

## NARFE scholarship program

This every year program began on February 1st and will run till April 24th. If you have children or grand children who are college age and looking for some grant money to help with college, you might tell them to check this out. You can find details on it and an application in the March magazine.
