I mentioned the recent news about the security breech of the Office of Personnel Management (OPM). Legislative news

<u>Fiduciary Rule</u>: NARFE has been working in support of a proposed Department of Labor (DOL) rule that would amend the definition of "fiduciary investment advice" under the Employee Retirement Income Security Act (ERISA) to ensure individuals saving for retirement are protected by a "best interest standard" when receiving investment advice. Under the current rule, the best interest standard does not apply to advice given on a one-time basis, advice regarding rollovers, or any advice on investing in an Individual Retirement Account (IRA).

In real terms, this means that a financial advisor could advise a federal retiree to move his/her Thrift Savings Plan (TSP) funds out of the TSP and into a similar fund with much higher fees, including commissions, which is not in the best interest of the investor.

<u>TSP Bill</u>: As part of the effort to pass trade-related legislation, the Senate attached policy language known as "fast-track authority" to H.R. 2146, a bipartisan bill to allow employees with mandatory retirement age such as federal law enforcement officers, federal firefighters, border protection officers, customs officers and air traffic controllers, to take money out of their Thrift Savings Plan (TSP) accounts without a penalty when they retire.

The House and Senate eventually passed the legislation and sent it to the President's desk.

GPO/WEP Repeal: Sen. Sherrod Brown, D-OH, introduced the Social Security Fairness Act of 2015, S. 1651, which would repeal the Government Pension Offset (GPO) and the Windfall Elimination Provision (WEP).

Similar legislation, H.R. 973, was introduced in the House by Rep. Rodney Davis, R-IL.

NARFE supports both pieces of legislation and has been working on the repeal of the GPO and WEP. NARFE members are encouraged to send their legislators a letter urging their support or thanking them for their support of the repeal.

New list of senior discounts

I recently ran across a website that listed a whole range of discounts that are available to seniors; restaurants, retail and apparel stores, grocery, travel companies and more. Age and discount amounts vary by location. Many of these locations are local to us and many are in other cities and states, but can be useful to you as you travel.

Update on OPM data breach

On Thursday, June 4, the Office of Personnel Management (OPM) announced that a data breach left 4.2 million active, former and retired federal employees' employment data vulnerable. If your data was compromised, you should have received a postal letter or email from OPM explaining what happened and what steps you can take to protect your information.

On June 12, OPM reported that a second breach occurred, but the number of individuals affected has not been substantiated by OPM. Media reports claim anywhere from 14-30 million people could be affected. No one affected by this breach has been notified yet. If you received a letter from CSID stating your data was exposed, it was in relation to the first breach. OPM is now reporting 22 million affected.

NARFE continues to be in communication with staff and leadership at OPM, including participation on conference calls and emails. On Monday, June 29, NARFE President Richard G. Thissen met with OPM and Office of Budget and Management leaders to discuss the breach and lack of information.

NARFE has setup a <u>website</u> page dedicated to updating members with information and resources on the breach. As they receive updates, it is posted on this webpage. If NARFE members have additional questions, they should contact NARFE's Federal Benefits Service Department. The Office of Personnel Management has also set up a <u>webpage</u> on information and answers to questions that you might have.

On June 17, NARFE sent a letter to OPM Director Katherine Archuleta expressing frustration at the lack of information being released. And on July 8, David Snell who is the NARFE director of the Federal Benefits Service Department testified before the House of Representatives regarding the data breaches and their implications for current and former federal employees.

I am sure that much more will be revealed about this in the days and weeks ahead. And it seems at this point in time, that this affects mostly current and former federal employees that had security clearances. But it is advised that federal employees, past and present, and all federal retirees monitor their financial accounts and report any activity that is not correct. Hopefully we will be limited impacted in all of this. I will pass along more news if needed.
