The insurance Open Season for this year has begun. You have from now until December 14th to make any changes to your health insurance plan, and/or dental and vision plans. Remember that you do not have to make changes unless the particular plan that you have has been discontinued Don't forget that this year the new Self Plus One health insurance plans are available. That may or may not save you money depending on your circumstances and insurance plan, you will need to compare rates to know.

The November issue of the NARFE magazine has several pages of information on this including the 2016 rates, that you can read and study. You can also go online to <a href="OPM.gov">OPM.gov</a> or to any of the websites for any insurance carrier that you may have or be interested in.

For annuitants and survivors, OPM should either mail or email you, information about the Open Season including your options and instructions for making changes. For those still working, your agency should supply you with this information.

You are advised to carefully consider what is best for your needs. Open Season generally is the only time that you can make changes to your insurance plans.

#### Legislative news—copied from a NARFE email

Congressional leaders and the Administration announced they had reached a budget agreement that will fund the federal government for the next two years (fiscal years 2016 and 2017). The budget includes a compromise fix, supported by NARFE, that addresses the projected 52 percent increase in 2016 Medicare Part B premiums for 30 percent of beneficiaries, including many federal retirees who do not receive Social Security benefits.

According to the 2015 Medicare Trustees Report, 30 percent of Medicare Part B beneficiaries were expected to shoulder the *full* cost of the 2016 premium increase. This is the result of the so-called "hold harmless" provision in Social Security law, which states that the dollar increase in the Part B premium is limited to the dollar increase in an individual's Social Security benefit. With no cost-of-living adjustment (COLA) in 2016, an estimated 70 percent of beneficiaries are held harmless, meaning that, for most, their Part B premium remains stable at \$104.90.

This left 16.5 million beneficiaries, including Civil Service Retirement System (CSRS) retirees who do not receive Social Security benefits, and Federal Employees Retirement System (FERS) retirees who are not yet receiving Social Security benefits, to shoulder the *full* cost of the 2016 premium increase, resulting in an increase of 52 percent, from \$104.90 to \$159.30 per month for most.

Under the compromise, the individuals who are not held harmless will see a standard premium increase to \$120.70 per month instead of the expected \$159.30. This is the amount Medicare Part B premiums would have risen had there been a COLA.

To make up for the lost revenue to the Medicare Trust Fund as a result of lower premiums, beneficiaries will be charged a monthly surcharge of \$3, starting in 2016. Therefore, premiums for most federal retirees who do not receive Social Security are projected to be \$123.70. The \$3 surcharge will not apply to those held harmless this year, but it will apply to those individuals in future years in which they are not held harmless. The surcharge is expected to last five years.

While this is not a perfect fix, NARFE expressed its support for this agreement because it would help many thousand retirees. NARFE thanks those who contacted Congress in support. The deal has been passed by Congress and signed by the President.
