Dues withholding

I was pleased to hear that one of our members recently converted to Dues Withholding way of paying for their membership dues. They will save money and not have to write a check each year to keep their membership active.

We have many more members in our chapter who could convert to this easier and better way of paying dues. Will you consider do this? It makes it better for me and our Membership Chair to keep up with current membership status.

You should find a Dues Withholding Application in the magazine and you can sign up at any time and it will take effect when your membership is due to be renewed. It costs only \$3.75 per month.

Legislative news

By the time that you get this newsletter, Congress should have returned from their August recess. I have received much in news relating to federal legislation and I am placing that below:

- On August 12, NARFE President Richard G. Thissen testified before the Department of Labor (DOL) in support of DOL's Conflict of Interest Rule Proposal, which would amend the definition of "fiduciary investment advice" under the Employee Retirement Income Security Act (ERISA) to ensure individuals saving for retirement are protected by a "best interest standard" when receiving investment advice. Under the current rule, the best interest standard does not apply to advice given on a one-time basis, advice regarding rollovers or any advice on investing in an Individual Retirement Account (IRA).
- A provision of the Social Security law prevents an individual's Social Security benefit from decreasing. This means that if there is no cost-of-living adjustment (COLA) and Medicare Part B premi-

- ums increase, an individual who has their Medicare premiums deducted directly from their Social Security check is "held harmless" from the premium increase.
- To calculate the 2016 COLA, the 2015 third-quarter average will be compared with the 2014 third-quarter average and the percentage increase, if any, will be the 2016 COLA. The new CPI-W figure for July 2015 was 0.19 percent lower than the average CPI-W for the third quarter of 2014. The August numbers will be released on September 16. The COLA will be announced on October 15.
- A provision in the Medicare law requires that 25 percent of all Medicare Part B premiums have to be paid by enrollees. According to the 2015 Medicare Trustees Report, about 30 percent of Medicare Part B beneficiaries will shoulder the full cost of the 2016 premium increase, resulting in a premium increase of 52 percent from \$104.90 to \$159.30 per month. This group includes federal retirees covered by the Civil Service Retirement System (CSRS).
- NARFE supports the Bill H.R. 3351 which would change the way that future Cost of Living calculations are done for those of us who are retired. The CPI-E Act of 2015 would more accurately measure seniors' cost of living. Currently the CPI-W index is used. NARFE members should send a letter to their Representative urging them to cosponsor H.R. 3351. Those of you who have computers, you can send that letter by CLICKING HERE. Those who don't should call 1-866-220-0044, ask to speak to Rep. Diana Black's office (or other, if different) and urge her to cosponsor this bill. Why not do so today?
- Retirement Fraud Prevention Bill, Introduced by Sens. James Lankford, R-OK, and Heidi Heitkamp, D-ND, the Representative Payee Fraud Prevention Act (S. 1576) would protect federal retirement funds from embezzlement by retiree representatives. The bill passed the Senate by unanimous consent and now awaits consideration by the House. Under S. 1576, the mishandling of funds from the Federal Employee Retirement System (FERS) and the Civil Service Retirement System (CSRS) by retiree representatives would be classified as a felony, granting federal retirees the same protection given to recipients of Social Security and veterans benefits. NARFE supports this bill.
