**Notes from last meeting**

The program was presented by Houston Bynum who is the Administrator at Happy Haven Home for Children. He presented a nice talk of that ministry which has been in operation for 51 years. The location is a 40 acre site which is in Cookeville, some may remember it as the old County Poor Farm. Houston has been with the work for 6 years.

It is a small children's home with currently about 8 children with a capacity of about 15. The take in mostly girls and young boys that are troubled or otherwise are at risk. Some have parents or grandparents that just cannot take care of them. They do get some referrers from the local government agencies, but limit that to the less troubled of them. The following is from their mission statement: "Happy Haven Children's Home seeks to help children grow in their physical, mental, emotional, social, and spiritual well-being".

While they must meet all state guidelines, they do not receive any funds from the state or federal governments. They do receive funding and donations from churches, individuals, businesses and some grants. Houston said that they had their annual fund-raising dinner scheduled the weekend following our meeting. They qualify for tax-exempt donations and I am sure they would welcome a donation from our members. Why not send them a donation in appreciation of speaking to our group. **Latest news on the COLA**

The February data came out about mid-March and it shows a continual decline in the Consumer Price Index CPI-W which determines the annual cost of living adjustments (if any) for federal retirees and S S recipients. The February change was .04 percent lower, making the change so far for the year to be, 1.4 percent lower. As you could guess, the recent cost of fuel is most likely the driving force, but since February gas prices are going back up. We will just have to see how these numbers play out for the rest of the reporting year which goes to September.

### **Legislative news**

NARFE has provided the following information on recent legislative action. I hope that you see that our national office is doing a lot in support of federal employees.

**Congress holds WEP hearing.** On March 22, the House Ways and Means Social Security Subcommittee held a hearing, "Social Security and Public Employees: Ensuring Equal Treatment." The hearing focused on the Windfall Elimination Provision (WEP); Government Pension Offset (GPO); and the Equal Treatment of Public Servants Act of 2015, H.R. 711, the WEP reform legislation introduced by Ways and Means Chairman Kevin Brady, R-TX.

H.R. 711 if passed would: For those who turn age 62 before 2017, the amount of the reduction will be determined by the Social Security Administration (SSA) actuary, but is estimated to be about 50 percent of an individual's current WEP penalty. The amount would be based on how much SSA expects to recover through increased enforcement of the WEP, as directed by the bill, on state and local government retirees who had underreported their government employment earnings. For individuals who turn 62 during or after 2017, the bill would replace the current WEP formula with a fairer one, saving most WEP-affected individuals about \$77 per month.

The hearing focused mainly on the WEP, and committee members from both parties generally agreed that the WEP unfairly penalizes retirees and reform is needed. No decisions were made, but Chairman Brady hinted that the committee may move to advance H.R. 711 soon.

**House committee approves FY17 budget resolution.** The proposed budget was passed by the House Budget Committee by a 20 to 16 vote. At it stands right now, it is uncertain if there is enough support to pass it in the full House.

The House budget proposed would include these items: An increase in retirement contributions for all current federal employees. A 10 percent reduction of the federal civilian workforce through attrition, whereby one employee would be hired for every three who leave government service. A decrease in the rate of return on the Thrift Savings Plan's G Fund. Increase postal employees' share of their FEHBP premiums.

Ahead of this vote, NARFE sent a letter to the committee members, telling them to leave any cuts to the federal community out of the budget.

**Senate Fair Act introduced.** Known as S. 2699, it would provide for a 5.3 percent across-the-board pay increase for federal employees in 2017, which is greater than the 1.6 percent pay increase proposed by President Obama.

### **NARFE Webinars**

NARFE has been for the past several months providing free online discussions on some very important subjects by way of webinars. These are video presentations by Tammy Flanagan, a federal benefits and retirement expert. I think that normally there is a cost to seeing these, but they are free to NARFE members.

Each one is shown live 2 times, and scheduled on a Tuesday and Thursday. You have to pre-register and be online on the specified website to watch these live as they are taking place. There is normally set aside time for those watching to ask questions. Those with email addresses set up with NARFE should be receiving notifications in advance of these.

These are also recorded and made available after the fact and you can go back and watch them again, or for the first time whenever you want. Right now I see that they have 5 of the past webinars available and I am not sure how long they keep them available.
