## 2016 NARFE Conventions

So far we have 2 members of our chapter who are set to attend the Federation Convention as a delegate. There is still time for others to go as a delegate or just as a member. I will have the necessary forms at the next chapter meeting and they are also on the Federation website and in the Federation Newsletter.

The Federation Convention this year will be on April 25-26 which is a week later than normal. Hosting the convention is the Knoxville Chapter and it will be at the MainStay Suites in Pigeon Forge. The room rate is \$79 and the registration costs is \$55 for both Monday and Tuesday. Larry Minniear has requested that chapters get delegates selected earlier this year to give time for him to assign delegates to the various committees. Delegates must be approved by our chapter which we can do at the meeting.

I hope you will consider going to the state convention this year. Spring is a good time to visit the area where the convention will be. The convention committee is working to make this an interesting convention and worthy of your time.

I want to call your attention to the work going on at the national level in regards to the Future of NARFE or now as it is called **Strategic Planning**. This will be a huge subject this year at both the federation convention and the national convention. It is clear that some changes to the association are needed as we move into the future and those changes could have a great impact on the local chapter, the federations and more. There is a special section that covers the work going on that can be found on the national website. I would encourage you to go there and study this information.

At some point, we should have some resolutions presented that we will need to discuss prior to the National Convention.

## Membership news

Membership numbers are always a concern. Not only do we need each of you to remain as a member, but we need new members as well. Remember, the more members that we have, the more influence that NARFE will have in persuading Congress to support our legislative goals.

There are ways to get new members, one is to hand one of our membership forms to someone that you know who is working for or has retired from any federal agency. Another way is to sign up your spouse as a member. We have many in our chapter who have already done that, but there are others who could do that. Let me encourage you to do that right away. Let me know if I can help.

## Legislative news

The latest that I have on current legislation is listed here, be sure to come to meeting to hear more about these items and more:

- **H.R. 711 WEP Reform Bill**—This bill would not repeal the Social Security Windfall Elimination Provision, but it would make some changes to reduce the penalties for some. For individuals who turn 62 prior to 2017, the bill would reduce the current WEP penalty on their Social Security benefits by a certain percentage, not to exceed 50 percent. For those turning 62 after 2017, the formula used to determine an individual's WEP penalty would be replaced with a fairer formula. I know those are not much details, but it is all we have been told. The bill is cost neutral and has a chance of passing. NARFE supports this bill.
- **Postal Reform Hearing**—On January 21st, the Senate Committee on Homeland Security and Governmental Affairs held a hearing on postal reform. NARFE has sent a letter to committee members stating the Association's opposition to mandatory Medicare integration and citing that postal retirees should not be forced to take health care coverage they do not want or need as a condition of keeping their current health care plan. NARFE is also opposed to another provision that would reduce Federal Employees' Compensation Act benefits by cutting them by 25-35 percent for workers and eliminating supplemental benefits for beneficiaries with dependents.
- **The omnibus spending package**—This contained wording which extends identity theft protection services for 10 years for all victims of the Office of Personnel Management's two data breaches. NARFE is pleased with this but continues to advocate and support S. 1746/H.R. 3029, the Reducing the Effects of the Cyberattack on OPM Victims Emergency Response Act which extends lifetime protection services for all victims.
- **FY 2017 Budget**—Congress has just begun work on this process which will take many months. The Fiscal Year 2017 finale budget is likely to bring cuts to the federal community. NARFE will be watching this and should have more to report as the process goes forward.

Again, I urge you keep up with the legislative items of concern by attending our meetings and checking out the Legislative Section of the NARFE website. Remember these items could affect **you**.
