## **2016 NARFE Conventions**

This year we will have the Tennessee Federation Convention and the National Convention. I hope that you read the news and information about both of these. You will find news of the Federation Convention in the *Tennessee Federation News* which is the newsletter that is sent to you in the mail 4 times a year. The November 2015; and the January and March 2016 issues have lots of information on this. For news on the National Convention, look to your monthly NARFE magazine. Also you can find out about both conventions online at the respective web-sites.

The Federation Convention this year will be on April 25-26 which is a week later than normal. That is because it will be in Pigeon Forge Tennessee and the committee had to schedule around other events in that area. Many changes are being planned for this year's convention compared to previous years. The opening of the convention will be on Monday this year which will leave more time on Tuesday for the business session.

Hosting the convention is the Knoxville Chapter and it will be at the MainStay Suites in Pigeon Forge. The room rate is \$79 and the registration costs is \$55 for both Monday and Tuesday. Larry Minniear has requested that chapters get delegates selected earlier this year to give time for him to assign delegates to the various committees. We will begin the selection of delegates at this month's meeting.

I hope you will consider going to the state convention this year. Spring is a good time to visit the area where the convention will be. The convention committee is working to make this an interesting convention and worthy of your time. Take your NARFE membership seriously, at these conventions, both state and national there is important business conducted that has great effect on our organization. If you have never been, or if you have, I hope that you will consider going this year. I will bring some Delegate and Registration Forms to the meeting this month.

At this time, I don't have much to report on the National Convention other than it will be in Reno Nevada, August 28—September 1. This will be the 34th NARFE National Convention which is held every 2 years. You may want to go to this convention and visit that area of the country. They have begun the process of requesting those interested in committee assignments. I can give you information on that if you are interested.

The work of the Strategic Planning Committee is ongoing and will be greatly discussed and decided at the both conventions. Watch for more details.

## **Chapter dues**

We recently made a change in the cost of our chapter dues to decrease them from \$11 to \$10 per year. The new total dues amount which includes the national and chapter dues are now: \$50 for 1 year, \$92 for 2 years (a savings of \$8), and \$132 for 3 years (a savings of \$18). I hope that you will take advantage of renewing for more than 1 year.

Those of you who renew annually (or 2 or 3 years) will see the new rate the reflected the next time your membership comes up for renewal. For those of us on Dues Withholding, will see the change take place on the anniversary date of when we went on Dues Withholding. I can tell you when that is if you want to know. That rate will change from \$3.75 per month to \$3.67 per month withheld from your annuity check.

While I am on this subject, I would be very pleased if more of our members would switch to the Dues Withholding method of pay NARFE dues. This allows you to get the advantage of the maximum discount on total dues (see above savings) and you will not receive those renewal letters in the mail or calls to renew. Neither do you have to write those checks or make other payments. There is a form to submit to go on Dues Withholding, you can find that in the monthly magazine. If you and your spouse are members, both can switch to this. Many thanks.
