#### Legislative report

Our NARFE Legislative Department is currently watching and reporting on several bills. Here is just a couple:

**Postal Reform**—The House Committee on Oversight and Government Reform held a hearing on this in May. Prior to this hearing our National President sent a <u>letter</u> to each member of that committee explaining the reform provisions that NARFE supports and the provisions NARFE opposes. That letter is available online for further information.

Veterans First Act—NARFE joined with coalition partners to send a letter to the Senate Leaders opposing provisions of the this bill, claiming that it would undermine due process and merit-based service protections for VA employees and allow undue political influence over the workforce.

This being an election year, at our last meeting, Dan Hilton who serves as our Legislative Chair of the candidates who are running for U S Representative for the 6th Congressional District. That is the district that most of us live in. Dan passed out some handout on these candidates. We encourage you to look over those that are seeking this office and make the best decision on who to vote for. If you have questions on the information that was shared, contact Dan.

#### **COLA** watch

The Consumer Price Index for retirees for the past 2 reports has shown an increase of a small amount. Of course we do not know yet what the finale report for the reporting year will show, but I ran across an article that I mentioned briefly at the last meeting that I wanted to go into more detail here. Some of you may have seen this, it was reported in the NARFE Newswatch weekly news digest entitled 'What is Worse Than No COLA? A Small COLA'.

Medicare officials are likely to recommend an increase if the Part B premiums in January 2017. If the finale report for the Consumer Price Index is not more than it was for the same report a year ago, then Social Security recipients will not have to pay the increase in premiums as it was last January. This is because of a provision in the Social Security rules. But that provision does not apply for federal retirees who do not receive Social Security benefits. For last year Congress passed a bill that limited the increase in Part B premiums for federal retirees and they only had to pay a portion of the proposed increase. This same bill passed at the end of 2015 provided a clause saying that if there is no COLA increase even for 2017, — continued

— then no one who has Medicare Part B will see an increase in premiums regardless of what Medicare officials recommend for next year.

But if there is a small increase in the COLA, then it all changes. Again for those who receive Social Security benefits, then the increase in Medicare Part B would only be equal to the increase in the COLA. Premiums for those who have Part B but do not receive Social Security like most federal retirees, they would be pay a substantial increase because the Part B trust fund is legally required to be in financial balance. In other words, if there is a small increase in the COLA, federal retires will have to make up the shortfall in the cost of Medicare Part B that Social Security recipients do not have to pay.

So I hope you can see that no increase in the CO-LA for next year would be financially better than a small increase for those that fall in the category I described. As of the report for April that came out in May, we are at a minus 0.34 percent toward the next COLA. The month of May numbers will be released on June 16th, and the last report is the September report which comes out in October.

#### **Membership report**

The NARFE Tennessee Federation Board has approved a Membership Incentive in order for us to find and recruit new NARFE members. The Federation will give any member a \$10 incentive award who recruits a new member. Those who get 2 or more, then the incentive \$10 per new member. This membership incentive runs from July 1, 2016 to December 31, 2016. In order for them to be able to tract your recruits then your name or Member ID number must appear on the new member's application form or otherwise show you as the recruiter of the new member.

I hope you will consider talking to potential new members and ask them to join, this could be a federal retiree or current federal employee. Membership forms are available at our chapter meetings an in the monthly NARFE magazine.
