### Dues Withholding

This is my annual plea for members to sign up for dues withholding. Many of our members have their dues taken out of their annuity check already, but many do not. It has many advantages compared to paying membership dues the conventional way.

It saves you money because you get the advantage of the 3 year rate which saves you \$18 over a 3 year period. You will no longer get mailed notices to renew your dues and not risk the fact that you may forget to send in your membership renewal.

Making the switch is easy, and there is a form for this in the January magazine on page 39. Fill it out and mail it in, it will take effect on your next membership anniversary date.

And speaking of Dues Withholding, I ask again that each of you who are currently on it to check to see that the correct amount is being withdrawn. I hesitate to bring this up because I want to promote Dues Withholding as the way to pay the dues, but this goes back to the new reporting system that NARFE is trying to put in place. I believe that some are being charge more than they should for Dues Withholding. Again the correct amount is **\$3.34 per month per member**. Each of you should have received a Annual Annuity Notice from OPM and the amount is shown on it. Let me know if it is incorrect. I have already contacted NARFE about this and I will keep you informed.
