It is that time of year to file your federal taxes for year 2020. Wages and income reported is in most cases taxable including retirement income and in some cases part of the Social Security benefits.

Be sure to gather all your tax documents needed to include on your taxes, most of which should have been sent to you either my mail or download. There is a above the line deduction this year for charitable contributions up to \$300 even if you don't itemize your deductions.

Though we did not have an Annual Meeting last year due to COVID and no chapter willing to host the meeting, this year one is being planned but in a different way. It will be a virtual meeting done online using the Zoom meeting program. Participants should be able to join in by computer, table, or phone connection.

It will be a one day event on April 21, 2021 beginning at 9:30am Eastern Time, 8:30am Central Time. It is not known how long the meeting will last. All who attend will need to get the Meeting ID and Passcode from the Federation President, Wayne Baker. The Federation Newsletter will also have details about this upcoming meeting as well. All Tennessee NARFE members are invited and encouraged to take part.

The purpose of the Annual Meetings is and has always been for the purpose of electing the officers of the federation, voting on any proposed Bylaws changes and resolutions and any other business to come up at the meeting. Under the current Bylaws, the slate of officers and proposed Bylaws changes must be voted on prior to the meeting date. At an in person meeting, there is the opportunity to meeting with other members from across the state, but that will not be likely with a virtual meeting.

This will be something completely new and I am sure there will be some problems along the way. Many groups and organizations are now doing online meetings these days rather than in person meetings.

#### **Member Death**

I am sad to report the passing of Bob Harris, he died suddenly on February 28, 2021 at the age of 86. Bob attended nearly all of our chapter meetings since joining NARFE in 2012 and moving to our area. Bob worked for the USDA during his federal career.

# NARFE's Legislative Accomplishments: For 2019-2020

I know that in recent years not much has been accomplished on behalf of federal workers and retirees in Congress, but our legislative department has been busy working for us there to both push for bills that would help and to block bills that would be harmful to the federal community. Remember there are a lot of bills that are introduced and we should be glad that someone is there to monitor all the activity. NARFE cannot take all the credit for these accomplishments but they did have a part in them. Here, I will just list the items, see the March issue of the magazine for details of these.

- Preventing cuts to earned pay and benefits
- Blocking the OPM reorganization plan
- Securing pay raises for federal employees
- Providing paid parental leave for federal employees
- Guaranteeing back pay for employees furloughed during government shutdown
- Suspending RMDs for TSP participants for 2020
- Securing Congressional hearing on nominees for the TSP board
- Extending the rehired federal retirees waiver authority
- Repealing the Cadillac tax
- Securing emergency funding for the Postal Service
