By now you should have noticed that your federal annuity and Social Security payment increased on the January payment based on the 5.9 percent Cost of Living Adjustment. And the change in cost (if any) in your health insurance was reflected on the February annuity payment.

Keep an eye out for the related tax documents that should come by January 31st to show the amounts received in 2021 for retirement benefits and Social Security benefits.

Continuing Resolution Through February 18 Signed Into Law

With just hours to spare, Congress avoided a government shutdown.by passing, and having the president sign into law, a bipartisan continuing resolution (CR) that provides government funding at fiscal year 2021 (FY 2021) levels through February 18. The December 3 deadline to fund the government was established by a previous short-term CR that was signed into law on September 30. The new CR gives Congress additional time to negotiate spending bills for FY 2022, although NARFE remains frustrated by government funding consistently coming down to the wire, leaving agencies scrambling to prepare for potential shutdowns.

The resolution does not include a raise or suspension of the debt ceiling—a limit that Congress sets on the amount of debt the federal government can borrow at any given time. The Department of Treasury currently estimates that Congress has until December 15 to act on the debt ceiling. Action on the debt limit is just one of several objectives in a packed agenda for Congress as the year comes to a close. Without a debt limit suspension, the federal government will risk defaulting on its financial obligations.
