#### **National Voting**

Voting for NARFE officers and Bylaws and Standing Rules changes goes live online July 15, 2022. The ballot will be in the NARFE August magazine (as far as I know) which you should receive by August 1, 2022. Voting ends on August 31, 2022.

To read information on candidates seeking office and/or the proposed changes to the National Bylaws, refer to previous magazines or go only to the NARFE website, Log in as a member, then look at the top of the page for **Member Quick Links**. Click on that and you should find where they list **2022 Election Information**. Since there are 4 candidates for President, you must indicate your preference by choosing your 1st, 2nd, 3rd and 4th choice.

Make you own decision on who to vote for, my recommendations are: Bill Austin for National President, Kathryn Hensley (unopposed) for National Secretary/Treasurer, Robert Allen for Region X Vice President.

All NARFE members can vote for National Officers, NARFE members can only vote for the Regional Vice President of the region they live in. Tennessee is Region X along with Kentucky, North Carolina, Virginia and West Virginia.

I am sure the voting process will be explained in the magazine or ballot. Be sure to read carefully to understand the process.

#### **Legislation News**

WEP and GPO: On June 7, NARFE National President Ken Thomas sent letters urging targeted House lawmakers to cosponsor a bill to repeal the Windfall Elimination Provision (WEP) and the Government Pension Offset (GPO), as NARFE's lobbying team pressed for meetings to discuss the issue. The letters arrived as nearly 1,100 NARFE members across the country contacted the remaining House holdouts, and as local NARFE leaders across the country made requests for meetings, as part of a full court press to secure the additional cosponsors needed to ensure a House floor vote.

Specifically, the letters pressed for co-sponsorship of the Social Security Fairness Act, H.R. 82. The bill, introduced January 4, 2021, by Rep. Rodney Davis, R-IL, would fully repeal both the WEP and the GPO. These unfair penalties significantly reduce Social Security benefits for more than 2 million beneficiaries, drastically affecting retirees living on fixed income.

Currently, H.R. 82 has 277 bipartisan cosponsors, 13 shy of the 290 needed to force a House vote. Per recent House rules, any bill that obtains 290 cosponsors may be placed on the House Consensus Calendar, allowing the bill to be considered so long as it maintains those cosponsors (or more) for 25 legislative days. Retirement Savings: In a unanimous, bipartisan vote, 28-0, the Senate Committee on Finance favorably reported the Enhancing American Retirement Now (EARN) Act on Wednesday, June 22. Mirroring its House counterpart, H.R. 2954, the EARN Act includes several provisions designed to aid Americans in the looming retirement crisis. Notably, the bill would increase both the current required minimum distribution (RMD) age and the catch-up contribution limit for employer-sponsored retirement plans, such as the Thrift Savings Plan (TSP).

The EARN Act is designed to expand access to retirement resources and provide Americans with more efficient retirement savings options for the future. Provisions include increasing the RMD age from 72 to 75 (effective after 2031), allowing withdrawals for selective emergency expenses, increasing the catch-up limit for employer-sponsored retirement plans from \$6,500 to \$10,000 annually for those age 60 to 63 (effective after 2023) and allowing employers to provide matching contributions for student loan payments as if they were elective deferrals. It would also allow individuals to distribute up to \$2,500 per year from their retirement accounts for payment of long-term care premiums without an early withdrawal penalty.

# Preferential Voting (Instant-runoff voting) Explained

The NARFE Bylaws state that national officers elected, must be by majority vote. Where there are only 2 candidates for an office, then this is pretty simple as one candidate will receive more than 50 percent of the votes cast. I have not seen the voting rules yet for this upcoming NARFE election, but it is my understanding it will go as follows.

When there are more than 2 candidates as there is this year for the national president, it is possible that neither of the 4 will receive more than 50 percent of the votes cast. If none of the candidates receive a majority then the candidate with the fewest votes is eliminated and their votes are split between the remaining candidates. This process is repeated until there is a majority winner. So when you fill out the ballot, indicate your 1st, 2nd, 3rd, 4th choice for President.
