#### **Member Death**

She was age 84 and is survived by her spouse, Herb McKay, 2 daughters and 2 stepchildren. Our condolences to her family at this time.

#### **Legislation News**

The Postal Reform Act of 2022 passed in Senate on March 8th. The legislation will improve the agency's ability to remain a public entity providing a crucial service to the American people while simultaneously protecting the earned health benefits of postal and federal workers and retirees. The bill passed with bipartisan support, 79-19.

The legislation gained NARFE's support after it was amended to address our concerns. In particular, changes were made to prevent unintended increases to Federal Employees Health Benefits (FEHB) program premiums for federal employees and retirees. And unlike past iterations of postal reform, this bill preserves choice for current postal retirees regarding whether to enroll in Medicare Part B. NARFE is also pleased with included provisions to repeal the burdensome mandate to prefund future postal retiree health benefits and the bill's codification of six-day mail delivery.

The Postal Service Reform Act of 2022 now heads to the President Biden's desk where it is expected to be signed into law.

After several continuing resolution bills passed this fiscal year, Congress, nearly halfway through the fiscal year, has passed a \$1.5 trillion comprehensive spending deal for the rest of fiscal 2022.

The Senate voted 68-31 March 10th. to pass a \$1.5 trillion omnibus bill that will fund federal government agencies for the remainder of fiscal year 2022, following in the footsteps of the House, which passed the measure the previous evening. The bill now goes to President Biden's desk.

This seems to be the order of business anymore, It has been years since they passed the regular spending bills which are required each year.

#### **2022 Federation Annual Meeting**

The date of the Federation Annual Meeting has been changed to Monday, April 18th. It was set to be on Tuesday of that week. I am not sure why the change. April 18th is the last day of the normal tax season this year and I have to work that day and will not be able to attend.

I have not seen a start time, but you can read more about it in the February issue of the Tennessee Federation Newsletter that all members should have received. You must register to attend and there is no cost. Those who register by March 31st could win a \$100 Early-Bird prize. Registration closes April 10th.
