Legislative Report

I see that NARFE is still trying to get the Social Security Fairness Act, H.R. 82, a bill to repeal the Windfall Elimination Provision (WEP) and Government Pension Offset (GPO), to the floor for a vote. The latest that I see is the House Ways and Means Committee removed it from the Calendar. It still can be voted on if they will advance the bill.

NARFE has been pushing this legislation for many years and I believe this is the first time that it is moving in the committee process.

Medicare Part B Premiums

The 2023 Medicare Part B premiums have been announced and surprisingly the rates are going down in 2023. The standard rate that most will pay is \$164.90 in 2023, which is a decrease of \$5.20 from the current premium of \$170.10.

This rate applies to those whose with a modified adjusted gross income of \$97,000 for single tax filers or \$194,000 for joint tax filers. For those over those amounts (up to the next threshold) the premium rate would be \$230.80.

NARFE Annual Membership Drive

Don't forget about our membership drive. New members are so very much needed. Think of those you know who are potential members and give them a copy of a magazine or membership form and ask them to join.

Any federal employee or retiree and their spouses are eligible to join. And you can make copies of the Membership Form if needed.

Additional Notes on the 2023 COLA

Last year the increase we received was 5.9%, this coming year it will be even more, 8.7%. That increase is the most since 1981. In that year the COLA was 11.2%. Most likely non of us were receiving retirement benefits back then.

I should note that if you retired under FERS, the COLA for you will be 7.7% this coming January.

While it is good to get an increase in retirement benefits coming in January, the increase does not reflect the real rising costs of goods. Listed are some examples of where increase are.

Gasoline +51%, Natural gas +18%, Electricity +15%, Used cars and trucks +26%, New cars and trucks +9% Beef +24%, Food +20%, Milk +15%.

The lists go on and on, and it varies somewhat depending on the location and source.. It appears that there is no end in site.
