Legislative Report

Current federal employees may get a 4.6% pay raise in 2023 if the president's proposal is approved. That amount will be split between a 4.1% across-the-board raise and an average of 0.5% increase in locality pay rates.

Congress passed what is called the Inflation Reduction Act. But from all reports it is far from that. It may in fact increase the overall inflation that we are experiencing. We will have to wait and see on this.

There are 2 bills before Congress that pertain to protections to federal workers. In one bill referred to as the Bill to Protect Merit-Based Civil Service. This would prevent presidential action from bypassing traditional merit-based rules unless Congress changed the laws to allow it. In an opposing bill, Public Service Reform Act if passed would allow all federal workers to be considered at-will employees. The intent of this bill is to make it easier to dismiss employees for poor job performance or for political reasons, it seems.

There are many other bills in the works and again I would recommend that you read the monthly section in the magazine that covers this topic.

NARFE Annual Membership Drive

NARFE national is once again having a membership drive. This brings in many new members each year nationwide.

From September 1 through December 31 of this year, members will receive \$10 for each NEW member who joins that you recruit.
