# **Legislative Report**

The Social Security Fairness Act of 2023 H.R. 82/S. 597, officially has a majority of support in the House of Representatives. The bill reached 223 cosponsors in early April, marking a significant milestone in the 118th Congress for NARFE's fight to pass the bill into law. However, we still need to accumulate more cosponsors to push the bill to a vote.

Click here to visit NARFE's Legislative Action Center to send your lawmaker a letter asking them to cosponsor this bill to finally repeal the windfall elimination provision (WEP) and the government pension offset (GPO). Just type in your address and our system will choose the right letter for you to send to your lawmakers.

H.R. 82 is now only 67 cosponsors shy of the 290 cosponsors needed to trigger the House Consensus Calendar rule process that would require either committee advancement or a floor vote. We need your support to get across the finish line, please contact your lawmakers today. It only takes a few minutes of your time.

H.R. 82 has amassed strong congressional support just four short months into this session of Congress, putting pressure on leaders to act. At the same time last session, the House bill had just 129 cosponsors. And as of April 14, H.R. 82 had the 2nd most cosponsors of any bill in Congress. Additionally, the Senate companion bill, S. 597, has reached 37 cosponsors, reflecting steady progress in both chambers..

NARFE National President William "Bill" Shackel-ford sent a letter to the leaders of the House and Senate Appropriations Subcommittees on Financial Services and General Government (FSGG) requesting support for two NARFE priorities in the fiscal year 2024 (FY24) FSGG appropriations bill. NARFE requested adequate funding for and continued oversight of the Office of Personnel Management's (OPM) Retirement Services (RS) division's customer service to federal annuitants, and the authorization of a minimum 5.2 percent average federal pay raise for federal employees in 2024.

NARFE remains concerned with the current customer service levels of OPM RS, as members have reported an inability to connect with the division to receive assistance and have described lengthy processing delays for retirement applications, survivor benefits claims and healthcare and other related changes. All told, the situation requires the attention of Congress. Fortunately, lawmakers and OPM recognize NARFE's concerns, as seen in the recent March 9 hearing before the House Committee on Oversight and Accountability, which highlighted some of the very issues NARFE seeks to fix. While OPM has offered solutions to ongoing problems,

many of which NARFE agrees with, the fixes will require continued congressional support and funding.

OPM requested funding in its FY24 budget request to move away from slow, paper-based processes and expand its recent online retirement application and utilize a digital case management system. This will allow for case processors to view information more easily and reduce the time necessary to process retirement cases. As part of its strategic objectives, OPM intends to introduce new technologies to improve retirement case management and annuity benefit calculations, enhance the capabilities of OP-M's Services Online to increase customer selfservice options, and provide training to Retirement Services personnel so that they are better able to support customers. OPM also requested funding to bring on 91 new employees for retirement processing enhancements, which will allow them to reduce backlogs and better serve federal retirees. NARFE called for adequate funding to support these efforts.

NARFE also urged lawmakers to appropriate funds for at least a 4.7 percent across-the-board pay increase, plus a 0.5 percent increase in locality pay for federal employees in its fiscal year 2024 FSGG appropriations bill. This 5.2 percent average pay increase is based on the relevant change in the Employment Cost Index (ECI), which measures the change of private-sector wages and salaries. NARFE believes that this raise, or higher, would ensure the gap between public and private sector pay does not worsen in a time of high inflation and when mission-critical skills gaps persist within the federal government. Current analysis by the Federal Salary Council shows that federal employees are paid 22 percent less than their private-sector counterparts.

NARFE will continue to urge adequate funding and oversight of OPM RS and encourage lawmakers to support a federal employee pay raise.
